# Coronavirus Disease (COVID-19)

## DISTRICT STATUS: LEVEL 2

Still no confirmed cases in Cameron, Willacy, & Hidalgo Co.  
(Review Contingency and Continuation Plans)

Los Fresnos CISD continues to actively monitor the Coronavirus Disease 2019 (COVID-19) situation in conjunction with local and federal authorities. As always, the safety of our students, staff and families remains a top priority, and we will act with an abundance of caution to protect everyone’s health and well being.

Los Fresnos CISD is currently operating at **LEVEL 2** as detailed in the accompanying chart. Adjustments to this chart may be made as we deem appropriate.

Much is being learned about this newly emerged disease. Health officials are recommending that local communities and schools should take the same basic preventative measures to protect against COVID-19 as we take to avoid the spread of common respiratory illnesses, like the cold and flu:

- Wash your hands with soap and water for at least 20 seconds.
- Avoid touching your eyes, nose and mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Stay home when you are sick and do not return to work or school until you are feeling well.
- Cover your coughs or sneezes with a tissue. (not your hands)
- Clean and disinfect frequently touched objects and surfaces.

Los Fresnos CISD staff is working proactively by encouraging these simple but effective habits with our students, closely monitoring illnesses like the flu and ensuring our campuses and buses receive thorough cleanings, especially in high-traffic, high-touch areas. Currently the Cameron County Public Health Department says that the immediate threat to our community is low. Should this change in the future, Los Fresnos CISD is prepared to protect our families through appropriate control measures.

In situations like these, rumors may cause unnecessary reactions and panic. Therefore, we encourage you to get information from credible sources.
